VERNON — After practicing law in New York City for more than a year, Attorney Michael Kopsick, who grew up in Tolland, decided to return to small town life.

He never looked back. Kopsick is currently Managing Partner at Kahan Kerensky and Capossela, LLP., in Vernon, where he has worked since 1989.

"I think in our market, east of the river area, our ability to provide so much experience in so many different areas is unique," the 59 year-old Tolland resident said.

The law practice's office is at 45 Hartford Turnpike in Vernon.

The business closed its satellite office in Storrs last year.

"I think we just figured that the use of remote meetings allowed us to provide that service without having a brick and mortar service in the community," Kopsick said.

He said more people got accustomed to meeting with professionals through Zoom, Teams or other virtual platforms so staff at the practice "took advantage of that."

Kopsick said clients at the Storrs office were being serviced mostly remotely for the last couple of years, "We're still actively seeking clients from the Storrs, Mansfield area and beyond, further east," he said. Slightly less than 40 employees work for the firm, including 15 attorneys.

The law firm was established in 1964 and covers a large range of law services, including: business and corporate law; criminal law; divorce and family law; elder law; estate planning, wills and trusts; land use and zoning; litigation; personal injury; probate and fiduciary administration; real estate, residential and commercial and taxation and taxpayer representation.

Kopsick was named Managing Partner at Kahan Kerensky and Capossela in 2021.

He has managed the practice's litigation department for many years.

Kopsick has handled a wide range of litigated matters in courtrooms throughout the state.

He now focuses on business disputes, debtor/creditor rights, foreclosure and employment law. Kopsick said typically, clients' legal programs cover multiple practice areas.

For example, he said, a real estate issue might involve issues requiring the skills and experience of those in the litigation practice, as well as, possibly, real estate.

Kopsick said having many disciplines under one roof enables a client to have "all their problems solved" with one firm versus needing to work with multiple practices.

Kopsick has a bachelor's degree in English from the University of New Hampshire and a law degree from Western New England College in Springfield, Mass.

He said he enjoys the variety of responsibilities his job entails.
